A. explain the importance of the cell cycle to the growth of organisms, including an overview of the stages of the cell cycle and deoxyribonucleic acid (DNA) replication models; **BI0.6.A**

B. explain the process of cell specialization through cell differentiation, including the role of environmental factors; and **BI0.6.B**

C. relate disruptions of the cell cycle to how they lead to the development of diseases such as cancer. **BI0.6.C**

The student knows the role of nucleic acids in gene expression. The student is expected to: **BIO.7**

- A.** identify components of DNA, explain how the nucleotide sequence specifies some traits of an organism, and examine scientific explanations for the origin of DNA; **BIO.7.A**
- B.** describe the significance of gene expression and explain the process of protein synthesis using models of DNA and ribonucleic acid (RNA); **BIO.7.B**
- C.** identify and illustrate changes in DNA and evaluate the significance of these changes; and **BIO.7.C**
- D.** discuss the importance of molecular technologies such as polymerase chain reaction (PCR), gel electrophoresis, and genetic engineering that are applicable in current research and engineering practices. **BIO.7.D**

The student knows the role of nucleic acids and the principles of inheritance and variation of traits in Mendelian and non-Mendelian genetics. The student is expected to: **BIO.8**

- A.** analyze the significance of chromosome reduction, independent assortment, and crossing-over during meiosis in increasing diversity in populations of organisms that reproduce sexually; and **BIO.8.A**
- B.** predict possible outcomes of various genetic combinations using monohybrid and dihybrid crosses, including non-Mendelian traits of incomplete dominance, codominance, sex-linked traits, and multiple alleles. **BIO.8.B**

The student knows evolutionary theory is a scientific explanation for the unity and diversity of life that has multiple lines of evidence. The student is expected to: **BIO.9**

- A.** analyze and evaluate how evidence of common ancestry among groups is provided by the fossil record, biogeography, and homologies, including anatomical, molecular, and developmental; and **BIO.9.A**
- B.** examine scientific explanations for varying rates of change such as gradualism, abrupt appearance, and stasis in the fossil record. **BIO.9.B**

The student knows evolutionary theory is a scientific explanation for the unity and diversity of life that has multiple mechanisms. The student is expected to: **BIO.10**

- A.** analyze and evaluate how natural selection produces change in populations and not in individuals; **BIO.10.A**
- B.** analyze and evaluate how the elements of natural selection, including inherited variation, the potential of a population to produce more offspring than can survive, and a finite supply of environmental resources, result in differential reproductive success; **BIO.10.B**
- C.** analyze and evaluate how natural selection may lead to speciation; and **BIO.10.C**
- D.** analyze evolutionary mechanisms other than natural selection, including genetic drift, gene flow, mutation, and genetic recombination, and their effect on the gene pool of a population. **BIO.10.D**

- C.** explain the significance of the carbon and nitrogen cycles to ecosystem stability and analyze the consequences of disrupting these cycles; and **BIO.13.C**

- D.** explain how environmental change, including change due to human activity, affects biodiversity and analyze how changes in biodiversity impact ecosystem stability. **BIO.13.D**
